#### (16)16.1 Subject and type Anchor device type B, Type: ABS Anchor Loop

# 16.2 Description

The anchor device type: ABS Anchor Loop (Fig. 1-2) is used to protect up to 3 people against falls from a height. The product consists of a 44 mm wide double laid webbing that is sewn at one end. An additional protective hose is placed around the belt and sewn firmly to the belt.

A D-ring is sewn into one end.

The installation can be carried out on an appropriate structural anchor with sufficient strength. Here, the fabric tape can be connected directly to the structural anchorage using a suitable connecting element. Alternatively, the loop can simply be looped around the structural anchorage or the free end can be looped through the D-ring around the structural anchorage (anchor stitch). At the free end or on both loops, the user can secure himself against falls from a height with his personal protective equipment.
